ADDITION TO IMDG CIRCULAR NO 2 AMENDED ON 29/08/2014

1. BACKGROUND

In addition to the IMDG circular no. 2 amended on 29/08/2014. According to the Port Rules for the commercial ports of South Africa and TNPA Standards and Procedures, adopted in terms of the National Port Act No. 12 of 2005 ("the Act) all IMDG handlers are hereby instructed to adhere to the following regarding IMDG handling in the Port of Durban
