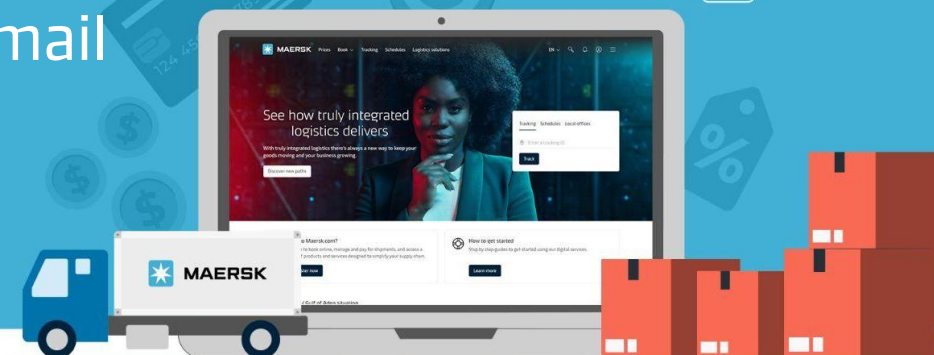


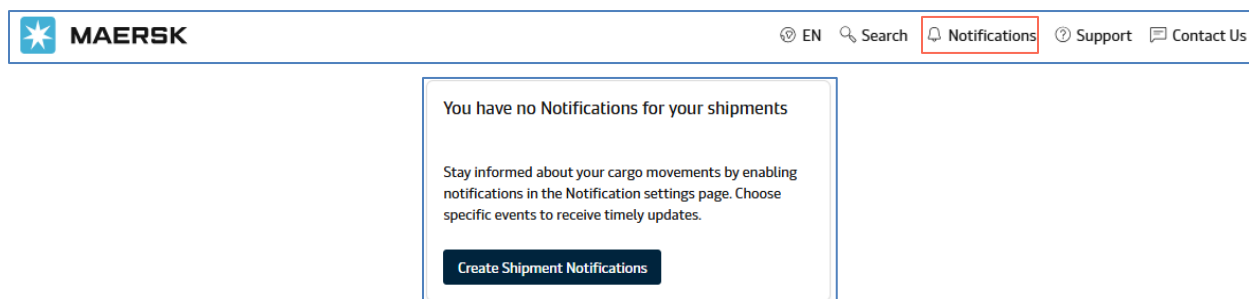
Subscribing to Email Notifications - BL, ARNO, TPC



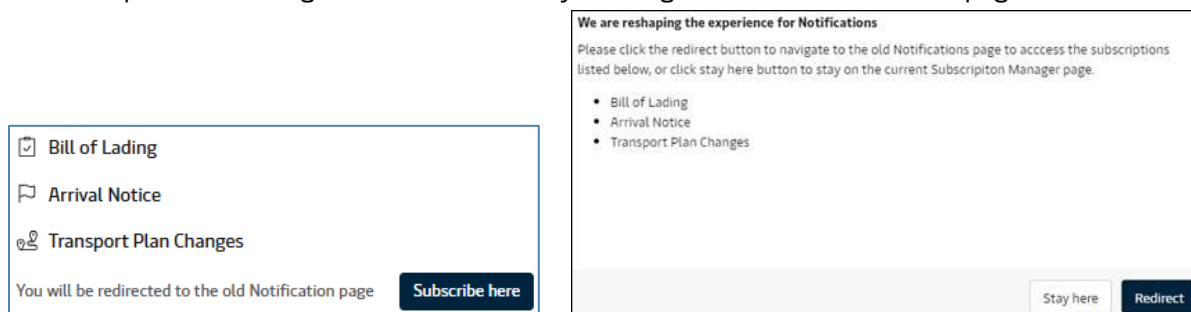
With this feature, you do not need to call or send an email to get the latest updates on your cargo. All you need to do is subscribe to email notification, and receive Bill of Lading (BL), Arrival Notice (ARNO) and Transport Plan Changes (TPC) straight to your inbox. Get the benefits as per below

- Subscribe and you will get notified if there are any changes with your Bill of Lading, Arrival Notices and Transport Plan Changes
- Customize your notification subscription based on your needs
- If your partner/colleagues do not have Maersk.com account, you can register their email also to subscribe to the notification & manage the subscription needs (Edit/Delete).
- For Import: Consignee will be the one responsible for managing the email subscribed for each notification.

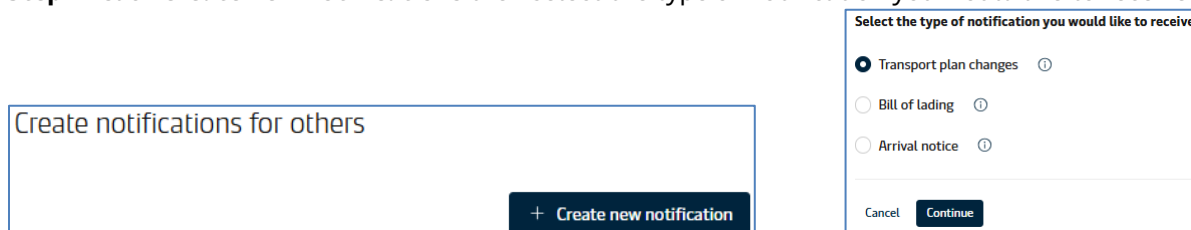
Step 1: Go to Maersk.com, login with your username then click **Notifications** then **Create Shipment Notifications**.

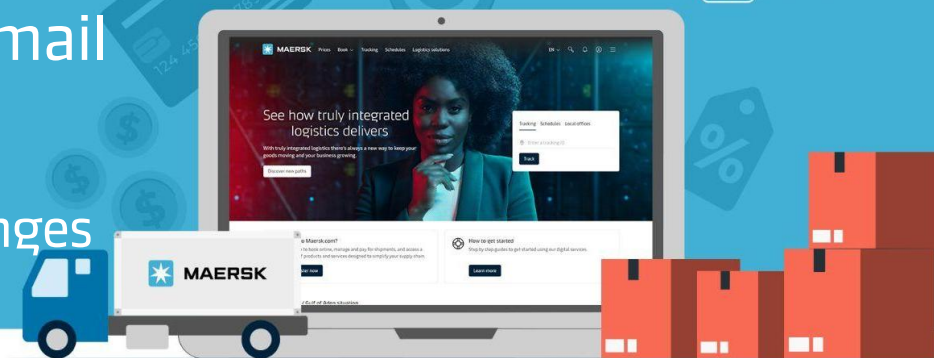
Step 2: Select **Subscribe Here** at the bottom of the page which mentioned Bill of Lading, Arrival Notice and Transport Plan Changes. Click **Redirect** so you will go to the old notification page for subscribing.



Step 4: Click **Create new notifications** then select the type of notification you would like to receive

You may also set criteria for shipments on which you would like to receive notifications through filters including the frequency to choose when you want to receive the notifications. Additionally, you may opt to receive notifications only for shipments where your company plays a role through Party roles section.

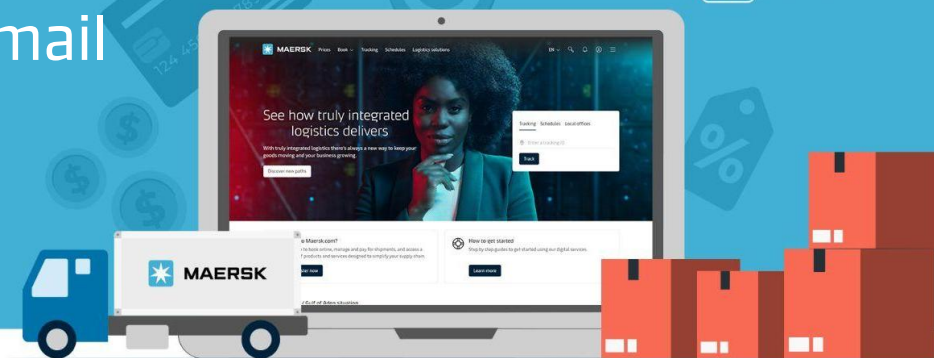

You may receive BL, verify copy, or certified true copy through email by selecting the applicable role and you may also select the type of bill of lading that you will receive either Waybill or Original BL. If you select EDI, you need to input EDI identifier.

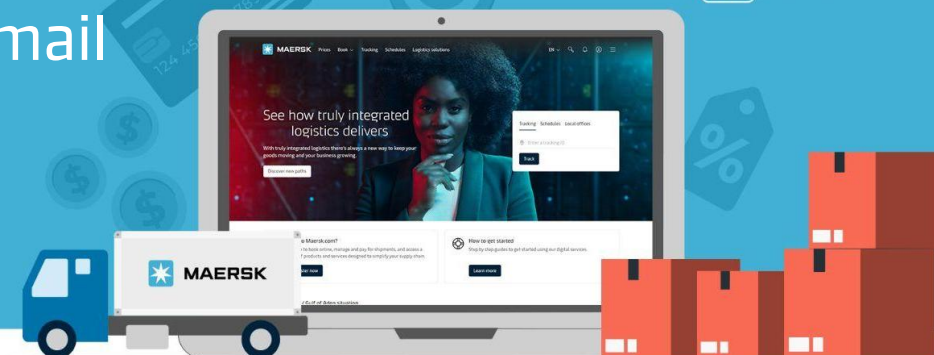

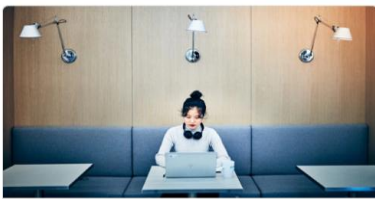
