# **Notice of booking process for Lithium Batteries**

We are finding incorrectly and/or missing declared dangerous cargo after cargo onboard that eventually harm the safety at terminal, vessels, and related co-workers continuously. However, in the business reality, we found case of cargo containing lithium batteries, it is frequently consolidated with other general cargo. Due to upon reason, we have been checked any commodity may include batteries that arranges consolidation with other commodities properly as follow IMDG regulation. That makes complicated booking and follow up process between Maersk and our valued customer. To solve the complexity of the booking process, please refer to the following guidance when you arrange a booking through Maersk.com or EDI/INTTRA.

## The shipper/consignor is fully responsible for correct classification and declaration of his goods.

If we find out any mis-declaration/un-declared of batteries after cargo onboard, then we will charge **as Mis-declaration fee.** And until we will verify commodities and required actions to proceed shipments safely, the cargo may not arrange transfer as planned due to safety reason.

### 1. Booking through Maersk.com

Please select right commodity at "Commodity" field. If your selected commodity on the web may not contain Batteries or Non-Lithium batteries, booking will be approved immediately.

### 2. Booking through EDI/INTTRA channel

Please input right commodity name through one of filed at Cargo Name / User define / Commodity.

a) If the cargo may contain **Lithium Batteries**, please refer to following commodity description.

b) If the cargo may contain **non-Lithium Batteries**, please refer to following commodity description.

### 3. Notes

**Nickel Metal Hydride Batteries**: If Nickel Metal Hydride Batteries packed separately and Gross mass weight is above 100kg must be declared as dangerous goods.

**Lead Acid Batteries - Non Spillable UN NO 2800**: This type of Battery needs to comply with IMDG SP 238.1 and 238.2 to be shipped as NON dangerous goods.

**Batteries, wet, filled with acid UN NO 2794:** Always acceptable as DG.

### **Battery Restriction:**

#### PORT:

**Ghana**: Acid-containing batteries are DG. Acid-free batteries are non-DG batteries. All automotive batteries must be declared as dangerous goods.

Syria: All kind of batteries are prohibited.

**Type of Package**: Lithium batteries are not allowed in drums, bags, and Jerrican. Please DO NOT use such type of packages.
