

**Letter of Consent to Appoint the Company
as Authorized Agent to Withhold and Submit Withholding Tax**

Hereby agree and consent **Maersk A/S C/O Maersk Line (Thailand) Ltd.**, hereinafter referred to as the “Company” being appointed as the authorized agent to withhold the withholding tax from freight, fees, and other charges due for export from Thailand, issue withholding tax certificates, submit withholding tax returns, and remit the withholding tax to the Revenue Department in the amount which the Company has withheld on behalf of the Appointer.

The Company has been approved to act as an authorized agent under the Withholding Tax Act by the Revenue Department, according to letter No. Khor. 0721/2902 dated April 3, 2024, and letter No. Khor. 0721/4903 dated June 18, 2024, as well as to comply with the announcement of the Director-General of the Revenue Department regarding income tax, issue No. 457 concerning the qualifications, criteria, methods, and conditions for being a representative for withholding income tax at the source and remitting withheld income tax on behalf of the payer as of April 11, 2025, which will be effective for income payments starting from July 1, 2025, onwards. The Company also acknowledges that this arrangement is very beneficial to the Appointer in reducing the working process, paperwork and costs. Moreover, the withholding tax data can be easily tracked and reconciled with the Revenue Department.

Should the Appointer identify any case where the Company has mistakenly processed tax withholding, caused delays, or acted incorrectly which results in tax penalties and surcharges, the company shall proceed to submit the withholding tax along with paying the tax penalties and surcharges to the Revenue Department correctly.
