

**Proper Cargo Description with Proper Shipping Name and HS Code for Bangladesh Inbound Shipment**

Dear Valued Customer,

Please be informed, in order to maintain safety compliance, Chittagong Port Authority (CPA) has been maintaining strict scrutiny on all inbound containers coming to Bangladesh. In multiple occasions, they urged the importance of providing Proper Shipping Name (PSN) of the cargo in the BL description and import manifest. In this connection, any shipment which doesn't reflect proper details of the cargo, they are further asking for relevant shipping documents to be confirmed about the cargo loaded inside the containers.

In such a scenario, there are instances where container had to be retained on board because of the detection of the DG cargo in the relevant shipping documents which was missing in the Import Manifest. Hence, we seek support all our clients to provide full details of cargo i.e., each of the cargo names and HS Code to be mentioned in the BL description so that we can make the identical declaration in Import Manifest.

For your reference we are sharing some of the recent cargo details which CPA has considered as vague description and we urge our customers for providing full cargo details and HS Code in the BL Description:
